## RESOLUTION No. June 17, 2014

### A RESOLUTION OF THE BOARD OF DIRECTORS OF CORNING HEALTHCARE DISTRICT ORDERING AN ELECTION, REQUESTING COUNTY ELECTIONS TO CONDUCT THE ELECTION, AND REQUESTING CONSOLIDATION OF THE ELECTION

**Whereas**, in regular meeting assembled this 17th day of June the Board of Directors has determined that,

**Whereas**, pursuant to elections code section 10002, the governing body of any city or district may by resolution request the board of supervisors of the County to permit the County elections officials to render specifies services to the city or district relating to the conduct of an election; and

**Whereas**, the resolution of the governing body of the city registry shall specify the services requested; and

**Whereas**, pursuant to elections code section 1002, city registry shall reimburse the county and pull for the services performed upon presentation of the bill to the city or district; and

**Whereas**, pursuant to elections code section 10400, whenever two or more elections, including bond elections, of any legislative or congressional district, public district, city, county, or other political subdivision called to be held on the same day, the same territory, or a territory that is in part the same, they may be consolidated upon the order of the governing body or bodies or officer or officers calling elections; and

**Whereas**, pursuant to elections code section 10400, such election for cities and special districts may be either completely or partially consolidated; and

**Whereas**, pursuant to elections code section 10403, whenever an election caused by a district, city or other political subdivision for the submission of any question, proposition, or office to be filed is to be consolidated with a statewide election, and the question, proposition, office, to be filled is to appear on the same ballot is provided for that statewide election, the district, city or other political subdivision shall, at least 88 days prior to the date of election, filed the board of supervisors, and a copy with the elections official, resolution of its governing board requesting the consolidation, setting forth the

exact form of any question, proposition, our office to be voted on at the election, as it is to appear on the ballot. Upon such request, the Board of Supervisors may board or the consolidation; and

**Whereas**, the resolution requesting the consolidation shall be adopted and filed at the same time as adoption of the ordinance, resolution, or order calling elections; and

**Whereas**, various district, county, state, and other political subdivision elections may be or have been called to be held on November 4, 2014;

**NOW, THEREFORE, THE RESULT IN ORDER THAT** THE governing body of the Corning Healthcare District hereby orders and election to be called the consolidated with any and all elections all called to be held on November 4, 2014, insofar as said elections are to be held in the same territory. I territory that is in part the same as a territory of the Corning Healthcare District request the Board of Supervisors of the county Tehama to order such consolidation under elections code section 10401 and 10403.

**It further resolved, and ordered** that said governing body hereby request the Board of Supervisors to permit the Tehama County elections department to provide any and all services necessary for conducting the election and agreed to pay for such services and

**Be it further resolved in order** that the Tehama County elections department conduct election for the following offices on November 4, 2014 ballot
