

OCTOBER IS FIRE SAFETY MONTH

FIRE EXTINGUISHERS

When to use a fire extinguisher:

Fire extinguishers can be helpful on a small fire. Quickly assess the following before deciding to use one:

- Have I alerted others in the building that there's a fire?
- Has someone called the fire department?
- · Am I physically able to use a fire extinguisher?
- Is the fire small and contained in a single object (like a pan or a wastebasket)?
- Am I safe from the fire's toxic smoke?
- Do I have a clear escape route?

Use a fire extinguisher when all of these questions are answered "yes." If you're unsure about whether or not it's safe to use a fire extinguisher, and for all other situations, alert others, leave the building, and call 911 from a mobile or neighbor's phone.

How to use a fire extinguisher:

Remember the word PASS

- · Pull the pin. Hold the extinguisher with the nozzle pointing away from you and release the locking mechanism.
- · Aim low. Point the extinguisher at the base of the fire.
- Squeeze the lever slowly and evenly.
- · Sweep the nozzle from side-to-side.

There are five primary types of fire extinguishers, each designed to put out different kinds of fires.

Letting go of what was or What could have been Makes room for buds of hope That are just around the bend



The Mighty Oak

Fun Facts

• Almost all species of oak trees live to be at least 200 years old. To be classified as an 'ancient', an oak has to be over 500 years old. Some oak trees can survive for thousands of years. One famous oak tree, planted by King John (of Magna Carta fame), has survived in Devon, England since the 13th century. Another famous even older oak is the Major Oak near Edwinstowe, a village in the heart of Sherwood Forest in Nottinghamshire. This tree is said to be as old as 1000 years and is believed to have been where Robin Hood and his merry men took refuge from the law.



- Oak trees were declared America's national tree in 2004, symbolizing the nation's strength and sturdiness. It is also the national tree of England, Estonia, France, Germany, Latvia, Lithuania, Poland, and Wales.
- Oak trees are associated with numerous mythologies and religions around the
 world. In Norse mythology, the oak tree is the sacred tree of Thor, the god of
 thunder. The Greeks believed oaks to be a sacred tree of Zeus, the king of the
 gods. It is also a significant tree to the Slavic god, Perun. The Bible makes
 mention of the oak tree at Shechem, and oak groves were planted by Druids for
 religious rites.
- Oak wood is well known for being hardy and strong. Oak makes solid furniture, ships, floors, and Yamaha drums are even made out of oak trees.
- Oak wood barrels are often used in the storage and manufacture of various alcohols. Wine, whiskey, and brandy are all stored in oak barrels. Some types of beer are oak barrel aged as well.
- Oak trees produce acorns, which are a fruit, not a seed. Oak trees don't start
 producing acorns until they reach around 20 years old. One tree can make 2,000
 acorns every year, but only about 1 in 10,000 will become a new tree.
- Pigeons, ducks, pigs, deer, squirrels, and mice all find a delicious snack in raw acorns, but the tannic acid found in acorns can be toxic to cattle, horses, dogs, and humans. However, by leaching acorns to remove the tannins, they can be made safe for human consumption.
- There are 20 species of oak trees native to California and more than 20 hybrids, with the most common being the valley oak, interior live oak, or blue oak. The valley oak is the largest oak tree found in California.
- No plants are fireproof but since large oak trees have thick, furrowed bark, they are more resistant to fire damage.
- The Jurupa Oak, also known as Hurungna Oak, in Riverside County, California is a Palmer's Oak that
 grows like a shrub in a colony. It is believed to be over 15,000 years old, which makes it possibly the
 third oldest living organism on Earth. There are no acorns on the Jurupa Oak. This oak clones itself
 but only does so after a fire, as new shoots grow on the scorched branches.

RESOLUTION NO. 9-20-22 A RESOLUTION OF THE BOARD OF DIRECTORS CORNING HEALTHCARE DISTRICT

PROCLAIMING A LOCAL EMERGENCY, RE-RATIFYING THE PROCLAMATION OF A STATE OF EMERGENCY BY GOVERNOR'S ORDER DATED MARCH 4, 2020 AND AUTHORIZING REMOTE TELECONFERENCE MEETINGS OF THE LEGISLATIVE BODY OF CORNINGHEALTHCARE DISTRICT FOR THE PERIOD OF SEPTEMBER 20, 2022 TO OCTOBER 20, 2022 PURSUANT TO BROWN ACT PROVISIONS.

WHEREAS, the CORNING HEALTHCARE DISTRICT is committed to preserving and nurturing public access and participation in meetings of the Board of Directors; and

WHEREAS, all meetings of the CORNING HEALTHCARE DISTRICT's legislative body is open and public, as required by the Ralph M. Brown Act (Cal. Gov. Code 54950 - 54963), so that any member of the public may attend, participate, and watch the District's legislative bodies conduct their business; and

WHEREAS, the Brown Act, Government Code section 54953(e), makes provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and

WHEREAS, a required condition is that a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558; and

WHEREAS, a proclamation is made when there is an actual incident, threat of disaster, or extreme peril to the safety of persons and property within the jurisdictions that are within the District's boundaries, caused by natural, technological, or human-caused disasters; and

WHEREAS, it is further required that state or local officials have imposed or recommended measures to promote social distancing, or, the legislative body meeting in person would present imminent risks to the health and safety of attendees; and

WHEREAS, the Board of Directors previously adopted a Resolution, Number 10-6-21 on October 6, 2021 finding that the requisite conditions exist for the legislative body of CORNING HEALTHCARE DISTRICT to conduct remote teleconference meetings without compliance with paragraph (3) of subdivision (b) of section 54953. This Resolution was re-ratified on November 16, 2021 based on a further finding that the requisite conditions continued to exist for the legislative body of CORNING HEALTHCARE DISTRICT to conduct remote teleconference meetings without compliance with paragraph (3) of subdivision (b) of section 54953.; and

WHEREAS, as a condition of extending the use of the provisions found in section 54953(e), the Board of Directors must reconsider the circumstances of the state of emergency that exists in the District, and the Board of Directors has done so; and

WHEREAS, such conditions now exist in the District, specifically, the State of Emergency declared by Governor Newsom on March 4, 2020, due to COVID-19. Pursuant to the Governor's subsequent Executive Order N-29-20, issued on March 17, 2020 a local legislative body is authorized to hold public meetings via teleconferencing and to make public meetings accessible telephonically or otherwise electronically to all members of the public seeking to attend and to address the local legislative body. Masks are now optional for fully vaccinated employees and members of the public. Based on Occupational Safety & Hazard Agency (OSHA) standards, those entering without a mask are self-attesting to being fully vaccinated; and

WHEREAS, the Board of Directors does hereby find that the rise in SARS-CoV-2 Delta Variant has caused, and will continue to cause, conditions of peril to the safety of persons within the District that are likely to be beyond the control of services, personnel, equipment, and facilities of the District, and desires to proclaim a local emergency exists and ratify the proclamation of state of emergency by the Governor of the State of California; and

WHEREAS, as a consequence of the local emergency, the Board of Directors does hereby find that the District shall continue to conduct meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and that such legislative bodies shall comply with the requirements to provide the public with access to meetings as prescribed in paragraph (2) of subdivision (e) of section 54953; and;

WHEREAS, the CORNING HEALTHCARE DISTRICT commenced virtual meeting protocols on April 21, 2020 which include options for public participation.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Directors of the CORNING HEALTHCARE DISTRICT as follows:

- 1. <u>Recitals.</u> The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.
- 2. <u>Proclamation of Local Emergency</u>. The Board hereby proclaims that a local emergency now exists throughout the District, and COVID-19 has caused, and will continue to cause, conditions of peril to the safety of persons within the District that are likely to be beyond the control of services, personnel, equipment, and facilities of the District.
- 3. <u>Ratification of Governor's Proclamation of a State of Emergency</u>. The Board hereby ratifies the Governor of the State of California's Proclamation of State of Emergency, effective as of its issuance date of March 4, 2020.
- 4. <u>Remote Teleconference Meetings</u>. The District Manager and Staff of the District are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including, but not limited to, conducting open and public meetings in accordance with Government Code section 54953(e) and other applicable provisions of the Brown Act.
- 5. Effective Date of Resolution. This Resolution shall take effect on September 20, 2022, and shall be effective until the earlier of October 20, 2022, or such time the Board of Directors adopts a subsequent resolution in accordance with Government Code section 54953(e)(3) to extend the time during which the legislative bodies of the District may continue to teleconference without compliance with paragraph (3) of subdivision (b) of section 54953.




